The Department of Medical Education & Research will conduct Common Counseling during the month of April/May, 2018 for filling-up of **50% State Quota PG (MDS) Degree seats in H.P. Govt. Dental College & Hospital Shimla. 50% State Quota and 50% Management Quota seats in private un-aided Dental Colleges** of the State, as per H.P. state merit drawn from NEET-MDS-2018 result by the Member Secretary-cum-Principal, H. P. Government Dental College & Hospital Shimla,(MDS) Counseling Committee.

#### **PROCEDURE FOR OBTAINING PROSPECTUS-CUM-APPLICATION FORM :**

The prescribed Application Form-cum-Prospectus for PG(MDS) Common Counseling can be download from the **websites of DME&R and Principal, H.P. Govt. Dental College & Hospital, Shimla, i.e. [www.hpgdcshimla.org](http://www.hpgdcshimla.org) & [www.hp.gov.in/hpdmer](http://www.hp.gov.in/hpdmer) w. e. f. 12-3-2018.** The Application Form be submitted **in original** complete in all respects either by Hand or by Registered/Speed post in the office of the Principal, H. P. Govt. Dental College & Hospital, Shimla-1 accompanied by crossed **Bank Draft amounting to Rs.1,500/-for General category AND Rs.1,000/- for SC/ST categories drawn in favour of Principal, H. P. Government Dental College & Hospital, Shimla on or before 24-3-2018 (up-to 5:00PM).** Thereafter no application form shall be accepted.

#### **ELIGIBILITY CONDITIONS:**

(i) **FOR DIRECT AND IN-SERVICE CANDIDATES STATE QUOTA SEATS :**

The candidates who qualified NEET-MDS-2018 and fulfills the eligibility criteria, terms and condition as laid down in the prospectus for PG(MDS) counseling, 2018. The In-service M.O.(Dental) candidates (Regular/Contract/RKS) are required to submit their application form along with **"SERVICE-CUM-NO OBJECTION CERTIFICATE"** from the competent authority as per specimen mentioned in the prospectus.

(ii) **FOR 50% MANAGEMENT QUOTA SEATS (Only in Private Dental Colleges):**

The 50% Management Quota MDS seats in Pvt. Un-aided Dental College of the State of H.P. shall be filled up from the qualified candidates of NEET-MDS-2018 on merit basis. Any interested candidate can apply for admission to MDS Degree Course subject to fulfillment of qualification and condition as prescribed in the prospectus. There is no condition of Bonafide Himachali/Graduate (BDS) of H.P. to apply for under this quota seats.

#### **QUALIFYING CRITERIA FOR APPLYING PG(MDS) COMMON COUNSELING-2018:**

(i)	General Category	50 <sup>th</sup> percentile
(ii)	SC/ST	40 <sup>th</sup> percentile
(iii)	Person with Disability	45 <sup>th</sup> percentile

**NOTE:** It will be the entire responsibility of the candidate to procure the prospectus from website and submit the Application form within the stipulated date. The Director, Medial Education & Research, HP and Principal, H. P.
