NOTICE FOR POSTGRADUATE (M D S) COUNSELLING-2017

The Department of Medical Education & Research will conduct Counseling during the month of April/May, 2017 for filling-up of **50% State Quota PG (MDS) Degree seats in H.P. Govt. Dental College & Hospital Shimla. 50% State Quota and 50% Management Quota seats in private un-aided Dental Colleges** of the State, as per merit drawn from NEET-MDS-2017 by the Principal, H. P. Government Dental College & Hospital Shimla-cum-Member Secretary Counseling Committee.

ELIGIBILITY CONDITIONS:

(i) **FOR DIRECT AND IN-SERVICE GROUP STATE QUOTA SEATS :**

Candidates whose names figures in the qualified list of State NEET-MDS-2017 result available on the websites (i) www.hp.gov.in/hpdmer (ii) www.hpgdecshimla.org and fulfills the eligibility criteria, terms and condition as laid down in the prospectus for PG(MDS) counseling, 2017. The In-service M.O. (Dental) candidates (Regular/Contract/RKS) are required to submit their application form along with "**NO OBJECTION CERTIFICATE**" from the competent authority as per specimen mentioned in the prospectus.

(ii) **FOR 50% MANAGEMENT QUOTA SEATS (Only in Private Dental Colleges):**

The 50% Management Quota MDS seats in Pvt. Un-aided Dental College of the State of H.P. shall be filled up from the qualified candidates of NEET-MDS-2017, available on the websites (i) www.hp.gov.in/hpdmer (ii) www.hpgdecshimla.org on merit basis. Any interested candidate can apply for admission to MDS Degree Course subject to fulfillment of qualification and condition as prescribed in the prospectus. There is no Bonafide Himachali/Graduate(BDS)of H.P. condition for these quota seats.

PROCEDURE FOR OBTAINING INFORMATION-CUM-APPLICATION FORM :

The prescribed Application Form-cum-Prospectus for PG(MDS) counseling can be obtained from the **Office of Principal, H.P. Govt. Dental College & Hospital, Shimla, Block-B, Student Section, Room No. 406, w. e. f. 27-2-2017** during working days on cash payment of Rs. 1500/- for General category and 1000/- for SC/ST categories. The application forms be submitted (in original) on or **before 27-3-2017 (up-to 5:00PM)** to the Principal, H. P. Government Dental College & Hospital, Shimla-171001.

QUALIFYING CRITERIA FOR APPLYING PG(MDS) COUNSELING-2017 IS AS UNDER:

(i)	General Category	50 percentile
(ii)	SC/ST	40 percentile
(iii)	Person with Disability	45 percentile

Candidate's less than above percentile in NEET-MDS-2017 is not eligible to apply for the counseling.
