- 1) The quotations are to be submitted in a sealed cover containing two separate and sealed envelopes i.e.
 - i) **Technical Bid Envelop:-** This envelop shall contain Tender form having technical specifications and terms & conditions of the tender both duly signed along with attested copies of required document.
 - ii) **Financial Bid Envelop:-** This envelop shall contain of rates only. The financial bid of the technically rejected bidders shall not be opened.
- 2) Technical bid envelop will be opened first and financial bid shall be opened of the technically qualified bids only.
- 3) Incomplete quotation/conditional tender will not be accepted.
