

**PUBLIC NOTICE**

2<sup>nd</sup> Round Counseling schedule for admission to MDS course in H.P.Govt.Dental College, Shimla and Private Dental Colleges in the State of Himachal Pradesh for the academic session 2020-2021.

It is for the information of all the eligible candidates desirous of seeking admission as per new cut off wide press notice dated 3-7-2020 to MDS course for the academic session 2020-2021 shall be conducted through online combined Centralized counseling for the Govt./Private Dental Colleges in the State of Himachal Pradesh on the basis of marks obtained in the NEET –MDS 2020. The tentative schedule for 2<sup>nd</sup> round of counseling is as under:-

- a) The candidates who have already registered themselves for the first round and wish to participate in the second round shall not be required to register again. The candidates who have got their document verification done during the first round of counseling are not required to get documents verified again. However they need to fill the choices afresh as per availability of seats in seat matrix.
- b) The candidates who have already been allotted seat in the first round of counseling shall have to give their willingness/option to upgrade themselves in the second round of counseling online other- wise they shall not be considered eligible for the second round of counseling
- c) The candidates who have joined on the allotted seat in the first round shall have a right to already allotted seat and this shall be changed only if he /she gets an updated and opted seat during second round .However the candidates who wish to participate in the 2<sup>nd</sup> round of online counseling will have to submit their preferences /choices afresh .
- (d) The candidates who have been allotted seats in the first round but did not join on the allotted seat will also have to give their willingness to participate and submit fresh choices for the second round.
- (e) All the candidates who are registering afresh have to deposit the registration fee as per prospectus i.e.Rs.1500/- for General Category and Rs.1000/- for SC/ST/OBC candidates.

(f) All candidates i.e. candidates already registered who have not taken admission and freshly registered candidates who wish to participate in the second round of counseling and want to opt for state quota seats / management quota seats in Govt. college or Private Dental college shall be required to deposit online an amount of Rs 20,000/- and 50000/- for state or management quota seats respectively as token money.


(g) All above payments should be done In the SBI Collect available on the HP Govt. dental college Shimla website \* (hpgdcshimla -> State Bank Collect ->Himachal Pradesh->education institution->RKS Dental College and Hospital Shimla->Misc—token money/Registration Amount

(h) In case of the candidates who have joined on the allotted seat, no amount is required to be deposited.

Note :-

- 1 The choice filled by the candidates for the first round of counseling shall be treated as null and void and candidates will have to fill fresh choices to be eligible for participating in the second round of counseling as per available seat matrix uploaded for 2<sup>nd</sup> round of counseling
- 2 If a candidate does not deposit the applicable payments as listed in (G) by 23:59:59 PM on 10<sup>th</sup> July and his/her candidature will not be considered for allocation . No relaxation in the dates will be entertained at any cost.
- 3 All the eligible in service candidates at the time of applying for admission to PG MDS courses for the academic session 2020-21 in the state shall be required to have a valid NOC and Incentive Certificate issued by the competent authority as per their respective post Graduate course admission policy for in service candidates.
- 4 In service candidates are required to upload the incentive certificate , which should clearly mention the percentage given by the competent authority at the time of filling of the registration form .
- 5 The above schedule is subject to change as per needs (if so required)
