The Technical Bid (Annexure-I) and Financial Bid (Annexure-II) in the enclosed proforma should be placed in the separate sealed envelope and both the envelopes should be placed in a large sealed cover which should be clearly super scribed as "**TENDER FOR SUPPLY, INSTALLATION, TESTING AND COMMISSIONING OF RO WATER PURIFIERS AT H.P.GOV. DENTAL COLLEGE & HOSPITAL, SHIMLA.**" should reach in this office on or before **11.07.2022** by 01:00PM either by registered post/ speed post/ courier/ by post addressed to the **Principal, H.P.GOV. DENTAL COLLEGE & HOSPITAL, SHIMLA-171001** which will be opened on the same day at 2.30PM in the office of the Principal, HP, GDC, Shimla in the presence of the bidders who wish to be present.

Technical bid envelop will be opened first and financial bid shall be opened of the technically qualified bids only those bidders would be opened who qualify the eligibility criteria and whose bids meet the Technical parameters maintained in the tender. Financial bid opening date and time would be communicated to the qualifying bidders after finalizing the technical bids.
4. Earnest Money Deposit (EMD) Rs. 6,000/-(Six Thousand only) in the shape of fixed deposit from(FDR) any Scheduled Bank in favour of Principal-cum-Chairman(EC), RKS, H. P. Govt. Dental College & Hospital, Shimla -171001, payable at Shimla should be submitted.
